This program provides foundational understandings via Waldorf educational workshops specializing in support for working class teachers in ECE-8 public and independent Waldorf schools through a series of philosophical lectures & discussions, recordings of classroom movement, teacher mentoring, administrative conversations inclusive of periodic on-site visits. These GRADALIS<sup>TM</sup> support services provide understandings of Waldorf Education over nine (9) months – August 1, 2021 to April 30, 2022.

This Enrollment & Tuition Agreement is between **GRADALIS Support Services** ('GRADALIS') and <u>OCEAN</u> <u>CHARTER SCHOOL</u> referred to as 'Ocean Charter School.' Tuition for the nine-month term is \$3,400.00 per Teacher-Attendee in this Agreement. Ocean Charter School agrees to pay full Tuition for each Teacher-Attendee at an amount of \$3,400 each to be paid over nine (9) months or in total within 30 days of signing this Agreement. The School agrees to pay \$3,400.00 per each of its 22 Teacher-Attendees for a total of \$74,800.00.

Each Teacher-Attendee understands they are responsible to purchase all books and materials. Should a Teacher Attendee withdraw from the training, the School understands it may be entitled to a refund according to the Cancellation & Refund Policy included at the end of this Agreement. Each Teacher-Attendee understands GRADALIS will retain the non-refundable first-of-the month payments, with subsequent pro rata payments in a revised appropriate amount. Accounts for School will be reconciled in May following the nine-month support services completion.

The Foundation chooses the following payment option:

€ Monthly at \$8,311 per month for nine months, August 1, 2021 through April 30, 2022, (i.e., \$8,111/month at the first of each month, i.e., first payment is due and owing as of August 1, 2021). € Total Tuition Fees for 22 Teacher-Attendees within 30 days of signing this Agreement, prior to GRADALIS first offerings of its services & workshops.

Payments may be made directly on the e-mailed invoice from DRP Financial Group, LLC or by check or money order

mailed to the GRADALIS office at 10661 Utrillo Lane, Northglenn, CO 80234. Failure to make my payments according to this agreement may put enrollment in the support services in jeopardy.

Materials generally used by the Waldorf teacher in their classrooms will be required for classes chosen by the attendee for art and movement. It is the responsibility of each Teacher-Attendee to bring these items to these classes, as directed by GRADALIS instructors.

GRADALIS may terminate this Agreement if Ocean Charter School fails to make payment to GRADALIS when such payment is due.

I, the undersigned, have read, understand and agree to abide by all provisions set forth in the foregoing Enrollment & Tuition Agreement. I acknowledge that this Agreement becomes a legal and binding contract once completed and signed by both Parties.
