- -The Board will discuss, and potentially approve, a series of transactions intended to finance the acquisition of property and the construction of a permanent facility for OCS. The transactions will include, but are not limited to, obtaining a secured loan from the California School Finance Authority for the proceeds from the issue of public bonds in an amount up to \$23,000,000, and granting the Finance Authority a right to receive funds previously awarded to OCS under California's Charter School Facilities Program to repay that loan. The Board will ratify the retention of counsel for the transactions. The Board will further ratify the appointment of OCS's officers and will authorize and direct them to approve and execute all documents necessary or advisable to complete the transactions.
- The Board will review, and potentially approve, an extension of its existing lease with the Marina Christian Fellowship for its Mar Vista campus.
