The transaction documents will include, but are not limited to, a Note Purchase Agreement, an Indenture, a Loan Agreement, and a Preliminary Limited Offering Statement. The Board will authorize and direct OCS's officers to approve and execute all documents necessary or advisable to complete the transactions and will ratify all actions taken in connection with the transactions.
