## **Director's Report**

The administration provided a long-term site update. The site task force is working with a real estate agent experienced in charter school site options. The task force is also discussing a shift in its focus to developing potential donor and partnership relationships that will open more options for increased funding. The Prop 1D funds may not be enough to meet our site acquisition needs.

There is also a parent site group being created in the community by OCS parents Joel Cichowski and Julia Caulder. Joel spoke to the board briefly about the outreach that has started among the parent community. He shared some meeting details and materials being distributed to spread the message about OCS's site needs and how parents can organize their support efforts through this group.

Executive Director Stephanie Edwards distributed and presented the OCS Director's Report. She shared information with the board about our diversity outreach efforts

and enrollment. She also gave an update on our academic programs, specifically in math and digital literacy and citizenship.

#### Finance

Graham Dye from Excellent Education informed the board that as of October 21, 2014, he would no longer be with the company. He is moving to the East Coast. Graham introduced Gordon Engstrom, who will be taking over for him and handling OCS's account after he leaves. Graham also introduced Samira Estilai, a VP at Excellent Education. Samira will be helping with the transition after Graham has left.

In light of the transition in staffing at Excellent Education, Wendy Teeter and OCS administrators will hold a public Finance Meeting on October 10, 2014 at 7pm on the Mar Vista Campus to review the budget.

Graham distributed the July financial statements and check register.
