Strategic Plan

The board has reviewed the current strategic plan. Ideas for revising the plan to more accurately reflect the school's values were discussed. It was agreed that a meaningful opportunity to discuss and set priorities would be necessary to make the appropriate revisions to our strategic plan.

Academic Assessment

Stephanie Edwards and Kristy Mack-Fett discussed current academic assessment markers such as 2014 CST Science scores for 5th and 8th graders as well as ongoing use of the Easy CBM assessments. The 2014 CST scores show overall improvement in student achievement in Science with a recognized opportunity for continued growth. And while the Easy CBM assessments are still in use, the faculty has found that they are sometimes an inconsistent marker of student achievement. However, it is still believed that they are the most appropriate assessment tools available. We assume that the Smarter Balanced assessments this year will generate student scores and with those we will have a better understanding of how student achievement is progressing with our implementation of Common Core.

Director's Report

Executive Director Stephanie Edwards distributed and presented the OCS Director's Report. She shared information with the board about the progress of co-location alterations at our Westchester Campus as well as a long-term site update. She also shared information about the expansion of our Intervention Program to include a second Intervention Teacher on the Mar Vista Campus this year.
