# **ADMINISTRATION**

### Prop 39/Co-location Update:

OCS and WESM administration continue to work collaboratively on school safety issues, parking and traffic issues, shared space use (softball field and Social Hall), and curricular partnerships.

# Mar Vista Campus Update:

#### Plumbing:

OCS continues to work with MCF to address particular plumbing issues on campus.

#### Electrical work:

OCS contracted with Powell Electric to complete necessary electrical repairs, including replacement of lighting ballasts to stop the flickering lights throughout the campus classrooms.

### Long Term Site Update:

OCS' site task force is investigating two private sites as possibly viable properties for our school's home. Advantages and disadvantages of both sites are being weighed in this initial investigation phase. OCS has hired the architecture firm of GKKworks to collaborate with our project manager and other consultants on site investigation, funding, compliance and timeline for our Prop 1d funds.

#### **Enrollment Update:**

2015-16 Enrollment as of September 28, 2015 is 465. Offers are pending throughout the grades.

# **Diversity Update:**
