This expenditure plan reflects input from various stakeholder groups in our community, including students, families, administrators and special education team members, teachers and our teachers’ union.

Students: Student input was gathered both through in class written surveys as well as verbal discussions with teachers about what their challenges have been during the pandemic.

Families: Family input was gathered through weekly written surveys over the past year, weekly public meetings with the directors on zoom, and individual meetings with families. For families that speak Spanish and Japanese (the two most prevalent languages at OCS), verbal input was requested and gathered in Spanish and Japanese.

Administration and Special Education Admin/Providers: The administrative team gave input during weekly administrative team meetings and based on CARE team referrals from the past year and a half. The special education team, including the APEIS, provided further input on student needs.

Teachers gave input on needs coming from the pandemic in multiple areas, including health and safety, student academic needs, and student social- emotional and mental health needs. The teachers' union, OCTA, also worked with administration on our Covid Safety Plan and Covid Protection Plan and our Covid Containment and Response Plan to ensure both student and employee safety during this time.

Tribes: No tribes are currently present or served by Ocean Charter School.

Civil rights organizations, including disability rights organizations: Ocean Charter sought and received input from parents of students with disabilities, from students with disabilities, and from the professionals who provide services for students with disabilities. In addition, input was received from social workers and school psychologists working under Charters Choice who advocate for students' civil rights and disability rights.

Individuals/Advocates: Ocean Charter sought and received input related to children with disabilities, English learners and other underserved students from our Homeless Liaison and from the equity consulting firm, The Lighthouse Group, who is advising the school on our equity plan.

#### A description of how the development of the plan was influenced by community input.

Ocean Charter School promoted opportunities for community engagement by hosting multiple sessions for sharing and input on the development of the plan, including:

- Weekly Teas with the Directors available to all families on zoom
- Weekly surveys
- Targeted sessions with specific groups, such as parents of students with special needs and parents of English Language Learners as well as parents of children in specific grade levels so that their input could be more focused on particular developmental stages of development

Ocean Charter School promoted opportunities for input from the public at large into the development of the plan by hosting Brown-acted public Board meetings and public Finance Committee meetings where the plan was discussed and developed that were accessible and open to the public and that were publicized on our website and in physical postings outside campus for the general public to see and access.

The development of this expenditure plan was influenced by community input in the following ways:

- Focus on health and safety: having adequate staffing to ensure protocols are upheld and communication is accurate and timely.

- Focus on academic support: a clear need for evidence-based strategies to support students with academic needs; emphasis on data driven intervention with measurable progress monitoring that is shared in a timely manner with teachers, parents and students; emphasis on in class support as much as possible (push-in); emphasis on support for teachers to differentiate lessons more in the classroom so students don't need to be pulled for intervention outside of class and so there are fewer students who need intervention (teacher training, modeling and support) – this looks like qualified intervention team members as well as instructional aides
- Focus on mental health support: students experienced and are experiencing different forms of instability and, for some, trauma – ongoing professional mental health support is essential in the form of informal counseling as well as ongoing faculty and staff training and development on trauma-informed practices and supporting healthy student mental health

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under

IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
