- e. Projecting net-loss (\$39,222)
- f. Cash \$1.8M actual including \$792,396 restricted cash and projected year-end \$468,878 and zero restricted. AR forecasted at \$1M.
- g. Discussion Items:
  - a. ADA Relief Proposal in Governor's May Revise budget provides a projected increase for OCS of \$298K. Forecast does not assume the ADA relief – need to wait for state budget approval.
  - b. Discussion on Fundraising forecast and shortfall of ~(\$120K) which was forecasted to a capital campaign line.
