- Recent incidents of antisemitism and hate speech in general at OCS Please read the following letter from OCS administration to all OCS families last Friday regarding recent events and OCS' approach to addressing these incidents as well as our ongoing commitment to the longterm work of building a community that promotes tolerance, respect, and belonging. Administration applauds the leadership shown by our 8th grade students and middle school teachers in the active promotion of our school values.

Dear OCS Families,

We are writing with heavy hearts to share that there have been a few incidents of antisemitism in the upper grades this past week at school. The incidents involved hate



speech and gestures, not physical violence. OCS/we understand that hate speech and gestures are also forms of violence, and we handled them as such. On behalf of OCS, we want to express our deep regret to our Jewish students and families that these events happened in our school community, and we want to assure you and all of our families that OCS is committed to creating a hate-free, safe, respectful environment for all of our students.

OCS takes all forms of hate speech and action seriously. We hold students accountable and work towards helping them understand how their words/actions impact others, why it matters, and what they can do to become positive actors in our community. We approach situations of hate speech/actions with a developmental lens, holding students accountable while also knowing that their brains are not fully formed, and that we can positively impact children now so that they grow up to make positive choices in the future. At OCS, we also practice Circle as a means of bringing both healing to all of those affected and restoration to the whole group as those who hurt others are held in the circle of the community as well.

To bring the ugly reality of hate speech out of the dark and into the light so we as a community can acknowledge it, proactively work to address it, and work towards building a more positive future, Ms. Mendoza's 8th grade students led a presentation today for all 6th - 8th grade classes titled "An Anti-hate Message". The scope of the presentation included some, but not all, forms of hate speech targeting a variety of groups and based on language that has been heard here among our students.

The purposes of the presentation were:

- To educate each other
- To come together as a community
- To understand that all of us can make a difference
- To reiterate the responsibility we have to ourselves, our peers and our community
- To raise awareness and ask questions, even if we don't have all the answers

The students highlighted core principles and values of our community, including:

Diversity and Inclusion



- Forgiveness
- A Caring Community
 - Childhood
- Appreciation for all living things
 - Open minds
 - Support

It was a difficult but necessary presentation that led to deeply thoughtful and sincere questions from students. We hope they are also bringing these questions home to you as their parents to explore answers together. And we ask all of our families to carefully consider and monitor what your children are being exposed to through access to media and the internet as the content they inevitably find there often includes traumatic images and messages of hate.

Our teachers will continue to work with these topics and questions in class as we all together strive to create a more peaceful world in which each of us sees and honors the humanity of each other.

We appreciate you as our partners in this journey.
