Educational Program

Student Performance

- Parent-Teacher conferences were held the week prior to Thanksgiving.
 Teachers met with parents individually to review Conference Forms reflecting student performance in all areas including academic, artistic, and socially-emotionally, and also to review NWEA assessment score reports. Teachers in grades 6th 8th also review Trimester Grade Reports.
- Academic and Behavioral Intervention: All three levels (Tier 1, 2 and 3) of OCS' vigorous Intervention program are being implemented consistently. Tier 1 involves classroom supports; Tier 2 involves additional supports of push-in our pull-out supports; Tier 3 involves referral for formal assessment to determine eligibility for an IEP.

2023 Upcoming

The 2023 Dashboard is currently embargoed until Dec. 15th when it will be made public. OCS has focused this past year on maintaining our areas of strength (low suspension rate, high ELA rate, medium math rate) and on correcting our areas for growth (chronic absenteeism and standards not met). Administration looks



forward to sharing with the Board the results of these efforts at the January Board meeting.
