Good portion size, however they claim that Ordo's breakfast portion is very small (OCS note: Ordo brought very big portion size breakfast for OCS's food tasting). School B says Ordo repeat the same foods month after month and it gets old... even though they offer a lot of different options per day, the items repeat monthly.
